PART "A" WAIVER AND RELEASE FROM LIABILITY AND COVENANT NOT TO SUE

The undersigned, for him/herself (hereinafter male gender includes female gender) and for the minor named below (both referred to herein as "Participant") and for his personal representatives, heirs and next of kin, in consideration of being permitted to enter for any purpose the Isles of Lake Hancock Ski Club (hereinafter referred to as THE LAKE), or permitted to participate in to enter, use, stay or utilize the property owned, operated and/or managed by members of the Isles of Lake Hancock Ski Club its members (or their family members, spouses, corporations, heirs or assigns) officers, directors, shareholders and employees, other participants, operators, officials, any persons at THE LAKE, including, and without limiting the generality of the foregoing, walking, riding, driving, skating, waterskiing and/or other water activities, compete, officiate, observe, work, eat, reside, or for any other purpose, agrees and represents that he has, or will immediately upon entering property known as THE LAKE, and will continuously thereafter, inspect THE LAKE portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon THE LAKE, participation, if any, in waterskiing and other water activities constitutes an acknowledgment that he has inspected THE LAKE and that he finds and accepts the same as being safe and reasonably suited for the purpose of his use, and he further agrees and warrants that if, at any time, he is in or about THE LAKE and he feels anything to be unsafe, he will immediately advise the officers of Isles of Lake Hancock Ski Club its members (or their family members, spouses, corporations, heirs or assigns) officers, directors, shareholders and employees, other participants, operators, officials, any persons at THE LAKE of such and will leave THE LAKE property immediately.

- 1. PARTICIPANT HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE The Isles of Lake Hancock Ski Club, Inc., its members (or their family members, spouses, corporations, heirs or assigns) officers, directors, shareholders and employees, other participants, operators, officials, any persons at THE LAKE, and each of them, their officers and employees, all for the purposes herein referred to as "releasees," from all liability to the undersigned, his personal representatives, assigns, hairs, and next of kin for any and all damage, and any claim or demands therefore an account of injury to the person or property or resulting in death of the undersigned, whether caused by the active or passive negligence, including gross negligence or design error on the part of THE LAKE, or its members, officers and directors, of the releasees or otherwise while the undersigned is in or upon THE LAKE property, and/or engaging in any endeavor whatsoever including, and without limiting the generality of the foregoing, walking, running, driving, riding, participating in waterskiing or other water activities, competing, officiating in, observing, or working for, or for any purpose participating in any events at THE LAKE.
- 2. PARTICIPANT HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon THE LAKE or in anyway competing, officiating, observing, or working for, or for any purpose participating in waterskiing or other activities and whether caused by the active or passive negligence of the releasees of otherwise.
- 3. PARTICIPANT SHALL HOLD HARMLESS AND INDEMNIFY Isles of Lake Hancock Ski Club Inc., all members thereof, their families, spouses' heirs and assigns, all shareholders, and all agents of these named parties and/or members harmless.
- 4. PARTICIPANT HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the active, passive or gross negligence of releasees, as well as any design error on the property or otherwise while in or upon THE LAKE and/or while competing, officiating, observing, or working for or for any purpose participating in any event or participating in waterskiing or any other water activities. Participant assumes all the risks of being at or participating in waterskiing, other water activities or any other activities of whatsoever type, including and without limiting the generality of the foregoing, walking, riding, driving, skating, eating, and/or any and all water activities.
- 5, IN THE EVENT OF LITIGATION arising from Participant activities at THE LAKE, Participant agrees to indemnify and defend on behalf of Isles of Lake Hancock its members (or their family members, spouses, corporations, heirs or assigns) officers, directors, shareholders and employees, other participants, operators, officials, any persons at THE LAKE in any such lawsuit.
- 6. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, covenant not to sue, and indemnity agreement is intended to be as broad and inclusive as is permitted by he law of the State of Florida and that if a portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
- 7. That in the event that any provision of this agreement is found to be unenforceable by a court of competent jurisdiction, said unenforceable provision shall be severed from the agreement and the remainder of the agreement shall remain in full force and effect.
- 8. That this written instrument is the entirety of the agreement of the parties and is a fully integrated and may only be modified by written agreement executed by all parties.

- 9. That in the event of a dispute between the parties relating to this agreement and/or any activity at the LAKE, releasee agrees to pay the actual attorneys fees and costs of The LAKE, Isles of Lake Hancock Inc. its members (or their family members, spouses, corporations, heirs or assigns) officers, directors, shareholders and employees reasonable related thereto.
- 10. That a facsimile, scanned or photostatic copy of this executed release shall have the same force and effect as the orginal.
- 11. That this release shall remain in full force and effect for a time period of one (1) year from the date or the execution of the release.
- 12. Releasee acknowledges that they have been advised by this document that they may wish to consult independent legal counsel prior to executing this document and agreeing to the terms thereof. That the releasee, on behalf of himself/herself/ or as guardian to a minor or incapacitated adult has independently chosen to not seek such independent counsel.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THF RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT AND COVENANT NOT TO SUE, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.

This waiver, release, covenants not to sue, and Indemnification agreement specifically embraces each and every activity at THE LAKE.

<u>PART "B"</u> PARENT/GUARDIAN WAIVER – RELEASE FROM LIABIITY

If Participant is under 18 years of age, the parent(s) or guardian(s) must execute in addition to the above, this following waiver:

The undersigned, referred to as the parent(s) and natural guardians) or legal guardian(s) of Participant does hereby represent that he/she (they) Is (are), in fact, acting in such capacity and agrees to save and hold harmless and indemnify each and all the parties herein referred to above as releasees from all liability, loss, cost, claim or damage whatsoever may be imposed upon said releasees because of any defect' in or lack of such capacity to so act and release said releasees on behalf of both of the undersigned.
